

TERMS & CONDITIONS

1. THE FULL PAYMENTMUST BE SUBMITTED WITHIN 72 HOURS AFTER THE APPROVAL NOTIFICATION HAS BEEN EMAILED

2. SHOULD YOU CHOOSE TO SET UP AN OPTIONAL SET UP, SPONSOR-VENDOR SET-UP IS 45 MINUTES PRIOR TO THE EVENT. ALL BOOTHS MUST BE COMPLETELY SET UP 15 MINUTES BEFORE THE EVENT START TIME. THE SPONSOR-VENDOR'S DISPLAY MUST REMAIN INTACT THROUGHOUT THE DURATION OF THE EVENT.

3. ONLY ONE BUSINESS PER TABLE. SHARING VENDOR TABLES ARE NOT PERMITTED.

4. NO GUARANTEED ATTENDANCE.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. SPONSOR-VENDOR SHALL NOT PROMOTE/SALE ANY GOODS OR SERVICES OTHER THAN THOSE DESCRIBED ON THE SUBMITTED APPLICATION AND DURING THE EVENT WITHOUT THE HOST'S WRITTEN CONSENT.

2. THE SPONSOR-VENDOR TABLE WILL BE PROVIDED AND SPACE SET UP UPON YOUR ARRIVAL WHICH WILL INCLUDE 1 TABLE WITH 1 CHAIR. THE SPONSOR WILL BE PROVIDED WITH TWO COMPLIMENTARY EVENT TICKETS. IF SPONSOR-VENDOR IS BRINGING AN ADDITIONAL PERSON(S), THEN AN ADDITIONAL EVENT TICKET(S) MUST BE PURCHASED. THERE WILL BE NO ACCESS TO ANY OUTLETS/ELECTRICITY FOR YOUR TABLE. YOU MAY PROVIDE YOUR OWN TABLE CLOTH, DECORATIONS, ETC. TO DECORATE YOUR TABLE.

3. SPONSOR-VENDORS SHALL CONDUCT THEMSELVES IN AN ORDERLY FASHION.

4. NO LOUD MUSIC, NOISE, OR SOUND AMPLIFICATION DEVICES SHALL BE USED BY THE SPONSOR-VENDOR'S STAFF AT THE LOCATION.

5. SPONSOR-VENDORS SHALL HAVE ACCESS TO THE LOCATION FOR UP TO 45 MINUTES AFTER THE EVENT'S CONCLUSION TO DISMANTLE AND REMOVE ALL THINGS BROUGHT TO THE LOCATION BY THE SPONSOR-VENDOR. THE SPONSOR-VENDOR SHALL LEAVE THE LOCATION CLEAN OF TRASH AND SUBSTANTIALLY IN THE CONDITION IT WAS BEFORE THE SPONSOR-VENDOR OCCUPIED IT.

6. THE SPONSOR-VENDOR HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS THE HOST AGAINST ANY DAMAGES OR CLAIMS THAT MAY ARISE IN CONNECTION WITH THE SPONSOR-VENDOR'S PRESENCE AT THE EVENT AND SPONSOR-VENDOR'S ACTIVITIES OF ANY KIND.
